



FALMOUTH CARNIVAL GUIDE TO FLOAT/PARADE SAFETY

Welcome to the Falmouth Carnival experience!

To ensure a safe and enjoyable day for all carnival and parade participants and viewers, please take note of the following safety rules for the event.

Vehicles

Any truck or vehicle in the parade must:

★ Be in good working order and roadworthy (current MOT).	
★ Have a valid vehicle excise license (taxed).	
★ Have tires in good condition.	
★ Have functioning turning indicators and lights.	
★ Provide evidence to support all the above requirements.	







The Driver

The driver must:

★ Hold a current driver's license appropriate for the vehicle being driven.	
★ Be appropriately insured for the vehicle being driven.	
★ Drive the vehicle very slowly, with a maximum speed of 5 MPH during the carnival.	
★ Avoid quick starts or stops that could cause the unit to jerk.	
★ Have assistants to help monitor the public stepping into their path.	
★ Not be under the influence of alcohol or drugs.	
★ Remain with the vehicle at all times, including when it is stationary and in position during the carnival parade.	
★ Be fully aware of the vehicle's controls and instruments.	
★ Follow the instructions of all event staff and/or emergency services on the day.	







Float Riders

Anyone riding on the back of the float must:	V
★ Ensure that anyone under 18 years of age is accompanied by an adult responsible for their safety and well-being on the float and while on the Falmouth Recreation Ground.	
★ Maintain a secure position; the safest position is sitting, which provides more stability if the truck halts suddenly.	
★ Ensure that anyone standing on the float is secure, using a handrail or an appropriate harness.	
★ Stand in the middle of the float, not on the edge where they could fall off.	
★ Wear clothing appropriate for the weather, keeping warm and being prepared for rain.	•
★ Have enough water or refreshments to last through the entire parade.	
★ Not to distribute gifts or advertising from or near the float, as this could lead to crowds stepping into the path of moving vehicles.	
★ Comply with noise levels deemed appropriate by production staff and/or the event management team and safety advisors if playing music on floats.	
★ Only leave the float when it is safe to do so; NO ONE is allowed to leave a float while it is moving.	
★ Not consume any alcohol or drugs at any point before	





Float Decor

- ★ Decorations must be firmly fixed to the float to prevent slipping, moving, or falling during the event.
- ★ Nothing may protrude from the sides of the float.

★ Decorations will be exposed to the weather and must remain in place if wet.


- ★ Decorations should be fireproofed (using flambar or another fireproofing liquid).

- ★ Appropriate fire extinguishers should be available on the float to tackle any potential fires.
- ★ The dimensions of the structure must not exceed the lowest height or narrowest width restrictions on the route. Maximum vehicle weight 7500 kg. Maximum Trailer width 2.5m Maximum trailer length

- Vehicles up to 3500kg, 7 Meters in length.
- Vehicles over 3500kg (Not exceeding 7500kg).12 Meters in length.
- ★ To ensure safety, all electrical appliances must be in safe working condition, tested and securely attached.

Route

Marching Entrants along with the Floats will leave The Falmouth Recreation (1) at 18:30 travel down Killigrew Street (2), The Moor (3), Webber Street (4), Market Strand (5), Market Street (6), Church Street (7), Arewenack Street (8) and finally Grove Place (9) the officially ending. Marching participants will disassemble on Events Square (10).

All collection buckets will be collected at the end of the Carnival Route Grove Place (For Floats) and Events Square (For Marching Parade).

Under no circumstances can entrants collect for their own charity or causes using their own collection buckets. All floats will hand in buckets at Grove Place (9).

Only official Carnival collecting buckets to be used. Unofficial buckets will be removed. (By law only persons over the age of 16 are permitted to collect).

For participants safety all Floats must return to the Recreation Ground (1) to disassemble or disembark passengers safely by traveling down Bar Road (11), turning right at the Falmouth Hotel (12) and following Melville Road (13) and along Western Terrace (14) to the Falmouth Rugby Club (1). All Marching Parade Entrants will finish in the safe havern of Events Square (10). It is the responsibility of all entrants to find a suitable and safe route home following the end of the Carnival.







Promoting your cause

Falmouth Carnival is a celebration, and each entry must contain an element of performance. This can be through music, singing, dancing or costume presentation.

Any banners should be to highlight your organisation only i.e. your name, website, social media and not a political statement.

Environmental Guidance

Falmouth Carnival seeks to be as sustainable as possible.

We work in line with Guidance from Falmouth Town Council and ask our entrants to comply with the following:


- ★ The release of Balloons are NOT permitted at Falmouth Carnival. This is because they cause significant harm to Marine life. If using balloons as part of your display please dispose responsibly after the Falmouth Carnival.
- ★ Single use plastic is prohibited (where relevant) i.e. plastic bags, drinks bottles, plastic cutlery, single use food containers and plastic cups. although we would prefer to consider other sustainable materials if possible.
- ★ Entrants are discouraged from giving out stickers.
- ★ Entrants are required to take responsibility of their own waste generated by their entry and take back and recycle.

Floats on Arrival

★ All floats are required to enter the Recreation Ground through the roundabout entrance and report directly to the Parade Coordinator Base. The Parade Coordinator will reach out before Carnival day to provide you with your designated arrival time slot.

All float exhibits must be securely fixed to the truck or truck bed, this will be checked by the carnival team prior to the float leaving the compound.
	Falling or lose objects on float	All	м	L	Any floats not meeting basic safety requirements will be removed from the procession. All float fixtures must be anchored to the deck of the truck to avoid falling. No float is to have any structure higher than 2 mtrs from roof of the cab.
	Vehicles used in an un-roadworthy condition	All	м	L	Normal Road traffic act and Road traffic Act Regulations Apply to all vehicles taking part in the procession. All vehicles on the day must provide evidence of a current MOT or vehicle testing license along with a copy of their insurance documents. The driver will also need to provide their driving license. (See Note 1 Below) The insurance document needs to be for general use, the use in carnival will be covered by the event organisers.

Any mains power wiring should be wired from an RCD trip switch, to isolate all power to the float. Any float requiring power must be inspected by a qualified electrician prior to entering the procession. The use of power on floats will not be encouraged, low voltage electrical equipment such as fairy lights of small battery powered lights will be encouraged
